- Returned Item Fee (Member's NSF Check Drawn on Another Financial Institution) \$ 34.00 per item.
- Returned Item Fee (Third Party NSF Check) \$ 5.00 per item.
- Check Cashing Fee \$ 1.00 per item if member does not have an Allegacy checking account.
- Automatic Savings to Checking Transfer Fee \$ 3.00 per transfer in excess of six (6) per month.
- NSF Bank Draft Item Fee \$ 34.00 per item.
- Single Service Fee \$ 3.00 per month.

**Money Market & Checking Account Fees**

- Account Reconciliation Fee \$ 25.00 per hour.
- Certified Check Fee \$ 10.00 per check.
- Standard Checking Account Service Fee \$ 2.50 per month.
- Standard Checking Account Excess Check Fee \$ .15 per check in excess of fifty per month.
- Eagle Plus Checking Account Service Fee \$ 5.00 per month.
- Golden Eagle Checking Account Service Fee \$ 2.50 per month.
- Global Access Account Service Fee \$ 10.00 per month.
- Check Printing Fee Prices may vary depending on style.

- Continuous Overdraft Fee \$ 5.00 per day on checking accounts that maintain a negative balance for more than ten (10) consecutive days.

- Returned Item Fee (Third Party NSF Check) \$ 5.00 per item.
- Stop Payment Fee \$ 30.00 per request.
- Photocopy of Check \$ 1.50 per check.
- Money Market Account Excess Check Fee \$ 3.00 per cleared check in excess of six (6) per month.

- Money Order Fee \$ 1.00 per money order.
- Special or Duplicate Statement Fee \$ 2.00 per statement.
- Teller's Check Payable to a Third Party \$ 1.00 per check.
- Incoming Wire Transfer Fee No charge.
- Outgoing Wire Transfer Fee \$ 10.00 per transfer.
- Outgoing Foreign Wire Transfer Fee \$ 10.00 per transfer plus expenses.
- NSF Bank Draft Item Fee \$ 34.00 per item.
